The meeting of the Berkshire County Retirement Board was called to order at 9:00 A.M. in the Retirement Office, located at 29 Dunham Mall, Pittsfield, MA. Present at the meeting were, Michael Ovitt, Chairman. Participating by video conference were Karen Williams, Elected Member, Mark Bashara, Elected Member, Beth Matson Appointed member and Paul A. Lisi, Jr., Advisory Board Member. A roll call vote was taken to open the meeting. Unanimous.

PUBLIC COMMENT:

Members of the public have an opportunity to address the Retirement Board as the remote link to the meeting was posted with the agenda. There were no members of the public attending the meeting or connecting remotely.

MINUTES:

1.) The Board minutes of the meeting held November 24, were signed and approved. A roll call vote to approve the minutes.

NEW BUSINESS: *Michael Ovitt left the meeting*

2.) The Board appointed a chairman to the Berkshire County Retirement Board. The chairman's position is a six-year term beginning on January 1, 2021. The Board members had several questions regarding the length of the term of Chairman that was established through MGL Ch. 32. How long had Michael Ovitt served as chairman, since the removal of Peter Arlos as Chairman in 2006. The board had a quick discussion regarding board chairmanships in city systems and how it differs from the county. Paul Lisi Jr., made a motion to reappoint Michael Ovitt chairman second by Mark Bashara, unanimous.

A roll call vote to approve the appointment of Michael Ovitt, Chairman.

Michael Ovitt returned to the meeting

3.) The Board accepted and will process an application for accidental disability benefits. An application for accidental disability benefits was made by Matthew Larson, Town of Lee. The Board discussed Mr. Larson's application and his ability to meet the standard for the Board to accept and process the application. The Board decided to request a medical panel with PERAC. Paul Lisi Jr, made a motion to accept the application and request a medical panel, second by Mark Bashara. Unanimous.

A roll call vote to accept application and request a medical panel.

4.) The Board reviewed medical panel decisions for accidental disability benefits as requested by Jason Hoellerich, Town of Cheshire. The Board set a date for a disability hearing of January 27, 2021, the hearing will be part of the regular monthly Board meeting. Motion by Paul Lisi, Jr. second Mark Bashara. Unanimous.

A roll call vote to set a date for hearing January 27, 2021.

5.) The Board reviewed and approved the amended 2021 annual budget for the Berkshire County Retirement System. The amended budget total for 2021 is \$587,000. The budget increase came from the inclusion of the cost of four family health plans rather than three individual plans. The budget approval also includes a 3% COLA increase for the staff salaries in 2021. Motion by Paul Lisi, Jr. to approve the total budget amount of \$587,000 and the 3% COLA increase for staff. Second Mark Bashara. Unanimous

A roll call vote to accept budget as proposed.

6.) The Board reviewed a separation agreement for Kyle Johnson, Town of Williamstown, a former member of the Berkshire County Retirement System. The separation agreement was reviewed by the Board and the Board determined with advice from legal counsel that they were not able to grant creditable service after the separation date of January 15, 2021, since Mr. Johnson was no longer performing any services in the town of Williamstown it cannot be considered "regular compensation". A motion was made by Paul Lisi, Jr. to grant creditable service until January 15, 2021, Mr. Johnson would be a member inactive after that date. Second Mark Bashara. Unanimous

A roll call vote to approve granting creditable service until January 15, 2021, then classify as member inactive.

7.) The Board reviewed a hiring plan for the staff position in the retirement office. The Board reviewed a job description for posting the open position. Paul Lisi Jr. made a request for several changes: include 3-5 years of commensurate experience, allow applicants to mail in a resume and cover letter and add perform any other duties as assigned by the director. The Board also requested that the salary range be included in the job posting and determined the salary range would be \$52,000-\$60,000. The deadline for application is February 1, 2021 or until job has been filled. The Board reviewed the timeline for hiring the new employee and agreed that we should have someone selected by March 15, 2021. The job will be posted in the Berkshire Eagle newspaper and website, Mass. Municipal Assoc. website only, PERAC website and Masshire.com website. A motion was made by Paul Lisi Jr. to approve the hiring plan as presented second by Mark Bashara. Unanimous.

A roll call vote to approve hiring plan as presented.
