#22/2020 Delayed FY21 Appropriations

The Board discussed the effect the recent Covid-19 pandemic may have on the ability of small towns to collect tax revenues. The only relief action the board can take regarding the annual retirement assessments is to waive interest on late payments. The current interest rate is 8.5%. The Board wants to be proactive in helping any of the towns and districts that might struggle to make a timely assessment payment due July 1, 2020.

Mark Bashara made a motion to waive interest due on late appropriation payments made through September 30, 2020, second by Karen Williams. Any appropriation payment made after September 30, 2020, will be subject to accrued interest at 8.5%. The Board asked that the letter indicate that Towns and Districts who would like to take advantage of the additional time to pay their assessment to call Sheila LaBarbera, Executive Director, of the Berkshire County Retirement Board. She will document the request for extended time to pay and to discuss payment options so that the retirement board can calculate cash flow over the three additional months. The Berkshire County Retirement Board also stated that they expect towns and districts that are able to pay their assessment in full by July 31, 2020 will do so, recognizing that the retirement board has an established funding schedule which relies on timely assessment payments to meet our monthly financial obligations.
