The meeting of the Berkshire County Retirement Board was called to order at 9:00 A.M. in the Retirement Office, located at 29 Dunham Mall, Pittsfield, MA. Present at the meeting were, Michael Ovitt, Chairman, Mark Bashara, Elected Member, Karen Williams, Elected Member, Paul A. Lisi, Jr., Advisory Board Member and Gerald Doyle Jr., Appointed Member.

PUBLIC COMMENT:

Members of the public have an opportunity to address the Retirement Board. Haven Orecchio-Egresitz from the Berkshire Eagle was present at the meeting.

MINUTES:

1.) The Board minutes of the meeting held March 27, 2019, were reviewed and approved **Voted to** approve the minutes.

NEW BUSINESS:

- 2.) The Board reviewed the proposed personnel policy updates for the Berkshire County Retirement System with Attorney Elisabeth Goodman. Attorney Goodman will edit and share edits with the Board. The Board will review the edited proposed personnel policy at a future date, possibly at a separate meeting.
- 3.) The Board reviewed an opinion from PERAC regarding the Chairman's compensation from the Berkshire County Retirement Board. Mark Bashara asked to have an item added to next month's agenda to discuss an increase of \$600 annually to the Chairman's compensation. Paul Lisi asked to have an item on next month's agenda to add a bylaw to change the Chairman's compensation to a stipend with no benefits eligibility. Chairman Ovitt abstained from this discussion.
- 4.) The Board reviewed an application for accidental disability benefits for James Salice, Town of Lee. After review of the disability application it was determined the applicant cannot be retired with a section 7 disability retirement as a matter of law. Mr. Salice separated from service and retired for superannuation on February 26, 2016, without an established disability, which precludes retirement for a subsequently matured disability. Additionally, the member's application which asserts that the applicant is disabled as a result of a personal injury, fails to provide information or documentation of a personal injury sustained "as a result of, and while in the performance of...duties at some definite place and at some definite time," as required by G.L. c. 32 sec.7.

Voted to deny the disability application. Karen Williams abstained.

5.) The Board reviewed the court action regarding the application for retirement benefits for Joseph Buffis. The Berkshire District Court upheld the decision of the Retirement Board to deny retirement benefits to Mr. Buffis. Mr. Buffis had submitted an appeal of the Judge's ruling to the Civil Appeals Court. On April 15, 2019, Mr. Buffis submitted a letter to the Courts and a copy to the retirement board withdrawing his appeal. Mr. Buffis will request a return of accumulated deductions rather than appealing for pension benefits.

6.) The Board approved a 3% Cost Of Living Adjustment on the COLA base of \$14000, for Berkshire County retirees who retired before June 30, 2018. The COLA will be effective for the July 1, 2019 pension payroll.

Voted to approve a 3% COLA

INVESTMENTS:

7.) The Board received from PRIT a statement of performance for March 2019. The PRIT Fund returned .80% for the month of March.

Voted to note the record.
